METHODOLOGY

The survey was designed and conducted by Public Religion Research Institute and funded by the Ford Foundation. Results of the survey were based on landline telephone interviews conducted by professional interviewers under the direction of Opinion Access Corporation. Those interviewed were selected by random digit dial (RDD) process. The survey includes three independent representative samples of the general public: national (n=1,201), Ohio (n=402), and Arkansas (n=402) for a total of 2,005 interviews. The national and state surveys were conducted from March 5-11, 2010.

The margin of error is +/- 3.0% for the U.S. general public at the 95% confidence interval. The margin of error for the state samples is +/- 5.5 at the 95% confidence interval. In addition to sampling error, surveys may also be subject to error or bias due to question wording, context and order effects.

Sample demographics were balanced by form to match target population parameters for gender, age, education, race and Hispanic ethnicity. The national sample was also balanced on census region. Weighting parameters were derived from an analysis of November 2008 Current Population Survey (CPS) data.

Weighting was accomplished using Sample Balancing, a special iterative sample weighting program that simultaneously balances the distributions of all variables. Weights were trimmed to prevent individual interviews from having too much influence on the final results. The use of these weights in statistical analysis ensures that the demographic characteristics of the sample closely approximate the demographic characteristics of the target populations.

Note: Due to an error during the data-collection process the voter registration questions (REGIST and REGICERT) were only asked of 71% of the national sample (N=854), 77% of the Ohio sample (N=308) and 78% of the Arkansas sample (N=313).
